Dear Mr. Settles:

Thank you, for the assistance you and Omega Paving & Construction Management Group, LLC provided Oktibbeha County in successfully completing 2, 7/10 mile road-paving (soil stabilization) projects, (1) being in my District (Dist 2). Based on our previous cost to stabilize a 24 ft. wide road with a 6-inch base with the use of your product Pave-ZYME (PZ 22-X) we realize an 80% saving. To clarify this saving it costs Oktibbeha County Road Dept Over \$50,000 per mile to stabilize (using soil cement) a 24 ft. wide road with a 6 inch base and only \$10,000 per mile to stabilize (using Pave-ZYME) that same 24 ft wide road with a 6-inch base.

In addition to Omega providing the 30 gallons of product to Oktibbeha County, we thank you for your technical assistance in training our Road Maintenance Staff on the application of the product for the 5 days it took to complete the treatment of the 2 road Projects on Cannon Road and New Light Road.

We further thank you for your assistance with facilitating the paper work necessary to qualify District 2/Oktibbeha County for a Federal Grant to fund the stabilization and Paving (Chip N Seal) of 300 miles of roads in Oktibbeha County. This, 300 miles of road will require 20 gallons/mile or 6,000 gallons. The final application should also reflect an approximate total cost of \$60,000/mile cost that will include total project cost/funding for soil remediation, chip seal and have 300 miles of permanent roads in Oktibbeha County.

It is my understanding that thru some of the contacts we provide you with Mississippi State Research Dept and a Local Videographer that you plan to do a Documentary

(ROADS OUT OF POVERTY, ROADS TO PROGRESS) on the how your Pave-ZYME (PZ 22-X) product can significantly reduce the cost for paving roads in Rural MS a minimum of 40-50%/mile from the conventional way. It is further my understanding that using your product (Pave-ZYME) that we will need to purchase 20 gallons/mile of Pave-ZYME to treat the 1-mile of road 24 ft. wide road with a 6-inch base, treatment of the shoulders and spraying the drainage ditches.
